If it is determined that extensive **roof repairs** are required and work can not be performed at that time, a written proposal will then be presented for the necessary repairs.

Emergency services are available at a minimum of \$195.00 during regular business hours as well as **Emergency** Tarping at a minimum of \$495.00. Please refer to the **Services** page on our website www.familyroofer.com for additional hours, pricing, and information.

Please note that LBR, Inc. can not be held liable for any leakage coming from mechanical equipment including air-conditioning units and/or air ducts, vents, pipes, or leakage caused by tenant/homeowner improvements by abuse/penetrations of the roof system.
